**The Trust, all Academies within the Trust and Shireland Learning Limited must comply with this policy.**

## Introduction

Schools are required under the Equality Act 2010 to have an accessibility plan. The purpose of the plan is to:

- Increase the extent to which disabled pupils can participate in the curriculum
- Improve the physical environment of the school to enable disabled students to take better advantage of education, benefits, facilities and services provided
- Improve the availability of accessible information to disabled students

Our school aims to treat all its students fairly and with respect. This involves providing access and opportunities for all students without discrimination of any kind.

Disability is defined by the Disability Discrimination Act 1995 (DDA):

"A person has a disability if he or she has a physical or mental impairment that has a substantial and long-term adverse effect on his or her ability to carry out normal day to day activities."

The **SEN and Disability Act** (2001) extended the **Disability Discrimination Act** (1995) to cover education.

**This duty requires Trust's** to produce an **Accessibility Plan** that identifies the action their Academies intend to take over a three-year period to increase access for those with a disability in three key areas.

The three areas include:

- Increasing the extent to which disabled students can participate in the **curriculum**.
- Improving the **environment** of the Academy to increase the extent to which disabled students can take advantage of education and associated services.
- Improving the delivery to disabled students **of information which is provided in writing** for students who are not disabled.

In addition, the **Disability Equality Duty** (2010) requires all Academy's to:

- Eliminate **discrimination** that is unlawful under the DDA.
- Eliminate **harassment** of those with a disability.
- Promote **positive attitudes** towards disabled persons.
- Encourage **participation** by disabled individuals.
- Take steps to take account of disabilities even if this involves treating disabled persons **more favourably**.

### **This duty requires us to;**

- Involve those with a disability in producing a Disability Equality Scheme (DES) and Action Plan.
- Publish the DES Action Plan.
- Demonstrate they have taken action identified to achieve outcomes.
- Report on progress, review and revise the DES annually

### **Shireland Collegiate Academy Trust Plan Guidance**

Our plan is drawn up in accordance with the planning duty in the Disability Discrimination Act 1995, as amended by the SEN and Disability Act 2001 (SENDA).

It draws on the guidance set out in "Accessible Schools: Planning to increase access to Schools for disabled students", issued by DfE in July 2002.

At all times the Trust will also be equally aware of the needs of disabled staff, parents and visitors.

### **Key Objectives**

- To reduce and eliminate barriers to access to the curriculum and to ensure full participation in the academy community for students and prospective students with a disability.
- To provide a caring and friendly environment.
- To provide resources to cater for the needs of the individual students.
- To promote an understanding of disabilities throughout the Academy and an awareness of the needs of students with a disability.

### **Principles**

Compliance with the DDA is consistent with the Trust's aims, equal opportunities policy, and the operation of the Trust's SEN policy;

The Trust recognises its duty under the DDA not to discriminate against disabled students in their admissions and exclusions, and provision of education and associated services not to treat disabled students less favourably to take reasonable steps to avoid putting disabled students at a substantial disadvantage to publish an Accessibility Plan.

In performing their duties, Trustees, Governors and staff will have regard to the DRC Code of Practice (2005);

- The Trust recognises and values parents' knowledge of their child's disability and its effect on his/her ability to carry out normal activities, and respects the parents' and child's right to confidentiality;

- The Trust provides all students with a broad and balanced curriculum, differentiated and adjusted to meet the needs of individual students and their preferred learning styles; and endorses the key principles in the National Curriculum framework, which underpin the development of a more inclusive curriculum:
  - setting suitable learning challenges
  - responding to students' diverse learning needs
  - overcoming potential barriers to learning and assessment for individuals and groups of students
  - all staff will be able to meet more fully the needs of disabled students with regards to accessing the curriculum.

## **Activity**

### **a) Education & related activities**

The Trust will continue to seek and follow the advice from professional organisations.

Within the curriculum, the Trust aims to provide a full access to all elements. Specifically, in all areas of Information & Communication Technology, the Trust will have consideration in planning facilities for;

- Wheelchair access
- Screen reader software
- Screen magnifier software for the visually impaired
- Features such as sticky keys and filter keys to aid disabled users in using a keyboard Screen Magnifier Software.

To develop communication skills in students, enabling them to express thoughts and opinions successfully through speech, writing and sign language as appropriate.

To give advice and support in curriculum subjects as appropriate, to enable disabled students to participate successfully in lessons within the mainstream Academy.

To ensure that the needs of all disabled students and staff are represented within the Trust.

To create positive images of disability within the academy so that students grow into adults who have some understanding of the needs of disabled people.

### **b) Physical environment**

The Trust will take account of the needs of students and visitors with physical difficulties and sensory impairments when planning and undertaking future improvements and refurbishments of the site and premises, such as improved access, lighting, acoustic treatment and colour schemes, and more accessible facilities and fittings.

The Trust will make itself aware of local services, for providing information in alternative formats when required or requested etc.

## **Action Plan**

The Trust requires every school to have an Action Plan based on a Accessibility Audit, which should be carried out every 3 years.
